

Jean Lambert MEP expenses summary

July - December 2010

Staffing costs

The Parliamentary allowance covers Jean's staffing costs. Each MEP can claim up to a maximum monthly allowance of 19,709 euros per month for staffing and associated costs such as pension, training, insurance, tax, and national insurance. For the above period, Jean's team consisted of:

All London based staff receive an additional London weighting of £5,000 per annum pro rata.

Office costs

General Allowance is claimed for Jean's offices' running costs. During the above period Jean received 4,202 euros a month. Any money that is not used is returned to the Parliament. Provisional figures for Jean's General Allowance spending for the time period specified are as follows:

Travel

Jean claims for her travel between her constituency and the European Parliament in Brussels. She also has to travel to Strasbourg approximately once a month to attend the European Parliament's plenary voting sessions. The Parliament covers all these journeys. For the six-month period specified Jean has claimed for:

The European Parliament also pays expenses for other parliamentary travel such as travel within the constituency and visiting other countries on parliamentary delegation visits. Jean usually comes back to her London constituency once a week. For the six-month period specified Jean has claimed for:
